It will also provide the facility for visitors to e-mail their MP, to congratulate or criticise them on their position. If visitors to the site send us their contact details when invited, the site will automatically follow up their action and e-mail them at a later date to ask them if they received a response from their MP, and what that response was.

This will ensure that supporters chase their MP for a reply, and that our records of MPs' views are kept up-to-date with the latest information.

The site will be supported by a brand new campaign leaflet, focussing on encouraging people to take action and contact their MP. This will be available in the usual large quantities soon

#### IDENTITY CARDS ABOUT TO COME TO ENGLAND - A CALL TO ARMS! BY JOHN WELFORD

If the government's current plans go ahead unchallenged it is almost certain that during the next twelve months a quarter of the population in England will be issued with identity cards. How do I know this? Because this is precisely what happened in Scotland last year.

The identity card in question is not the card as explicitly described in the Identity Cards Act 2006 and scheduled for issue in two or more years time. No, this is entirely different it is the national multi-

purpose entitlement card, popularly referred to as not, of course, be permitted in Germany. the pensioner's bus pass. But make no mistake, this IS an identity card. It is NOT a card that is SIMI-LAR to an ID card, or a card that MIGHT BECOME an ID card; it IS technically an ID card. Moreover, with appropriate function creep it is intended that in due course everyone in the population will be required to use these cards for access to their local services (+ devolved services in Scotland). And inevitably at an appropriate stage the card and its functions will be subsumed into the UK ID card scheme. At a stroke this will finally bring into being full transformational government.

Well this at least is the very bad news. The GOOD NEWS is that something can be done about it. For the plan to succeed it obviously requires the consent and active co-operation of the local authorities. Experience in Scotland has shown that local authorities have been kept in the dark about the true nature of these developments - and remain in the dark. A key requirement for English NO2ID groups, therefore, will be to educate their local authorities about what is planned and what remedial action should now be urgently taken.

In the following I go into more detail about what has been happening in Scotland and also my suggestions for the kinds of campaigning actions which I consider should now be taken.

A government announcement by Ruth Kelly was made three weeks ago - and strategically delivered in the middle of the LibDem Conference. It stated that the 'bus pass' entitlement card scheme, having been trialed in Scotland and Wales during the past two years, is now to be extended to England. I have still not seen this reported in any newspapers yet, but came across it in PublicTechnology.net. I have flagged up this news item on the NO2ID Discussion Forum here: http://tinyurl.com/2a83n3

- **1.** The new so-called bus pass is in fact a 'Trojan horse' identity card. It conforms to the ITSO 'smartcard' specification, carries an RFID chip, and is, I understand, technically very similar to a London Transport Oyster card.
- The registration procedure is simple, but it involves the unique numbering of pensioners and disabled people and the creation of a centralised database of people's potential details. for shared use for libraries. health departments, etc. Such an ID card would

- **3.** The application form and surrounding publicity have been hugely deceptive, with all the emphasis placed on 'the bus pass', and the centralised database not referred to as such anywhere.
- 4. Pretty well everybody has been completely taken in by the card: pensioners, most of the press, local councillors, etc. One of the very few cautionary notes I spotted was by Help the Aged (Scotland), who, taking note of the potential extended uses of the card were wise enough to recommend applicants to "read the small print".
- 5. As far as I know, out of the million or so people who applied for the card only one person sent it back, demanding a proper bus pass - and that was me! I am still in the process of demanding a proper bus pass and also trying, with some difficulty, to get my story onto the front page of a Scottish national newspaper.
- **6.** The problem with getting my story published in Scotland appears to relate to the anomalous allegiances of the national editions north of the border. While the story could do significant electoral damage
- to Scottish Labour it also has the potential to give a great boost to 'Braveheart' Alex Salmond and thence to the cause of independence. Now while there are newspapers which might welcome an opportunity to do damage to Labour in Scotland (e.g. the Scotsman and the Scottish Daily Mail), such papers are also pro-Union. Conclusion - I may soon have to give up on the Scottish press and take my story to a London newsdesk.
- From January of this year school students in Scotland have been invited to apply for a similar kind of 'entitlement card', which offers cheap bus travel. Some schools are choosing to use the cards for access to school meal services - and so the cards are already functioning as multi-purpose ID cards.
  - **8.** Early plans are now being made to of-

fer cards to all citizens, for access to council-run services, etc.

This obviously presents a new and vitally important campaigning issue to be confronted by all NO2ID groups, and especially now those in Eng-But also it should provide a new valuable springboard for getting our larger NO2ID message across. Fortunately, the English groups are in a good position to exploit the knowledge which we have been able to gain north of the border. In Scotland we had no such advanced knowledge.

2. WHAT COUNCILS CAN BE DOING NOW. In short, engage in some local democracy! Councils do not need to withdraw entirely from the entitlement card scheme (it would probably, in fact, be financially disadvantageous to do so). On the contrary, at a minimum all they need to do is to commit themselves to issuing their cards merely and quite explicitly for single-purpose bus pass use. The cards will probably not be issued until early next year (and ready for use on 1 April), and so there may still be time to arrange for the cards to carry an appropriate title: 'bus pass', 'concessionary travel' or similar. Note that in Scotland the cards are customised for each local authority. Thus, there is an Edinburgh card, a Glasgow card, etc. So a similar scheme in England should allow scope for any 'rebel' authority to choose to have its cards marked up, say, as bus passes. Ironically, Scottish entitlement cards are completely titleless, with no indicaactually what they are! See: http://www.jwelford.demon.co.uk/snec/snec.jpg

The Scottish application forms contain a section: "Part 3: Request for consent to share data". In effect, this is requesting applicants to sign away their statutory rights as laid down in current Data Protection legislation. This request would obviously be redundant for those rebel authorities issuing single-purpose bus passes, and so this section of the form, together with the final page of the form containing explanatory information on 'data sharing and data protection', should, if possible, be blanked out or otherwise cancelled. (Note that registrations have already started in some places, with cards being issued in the run up to 1 April 2008.)

Since the cards are issued centrally it seems inevitable that a pensioner's details are going to end up on the central national database. There is an opt out offered, but whether this will amount to anything in practice remains doubtful. However, the information is very basic, and so long as the card itself is functioning solely as a single-purpose bus pass this should, I think, present a relatively minor problem.

To conclude. If just a few English councils can be persuaded to opt out of the card's data sharing agenda this could, I think, be highly embarrassing for the government and could generate sig-

For any council which is deadopted an anti-ID card policy you need to point termined to co-operate with the government's ID card agenda, you could still encourage a few pensioners to become refuseniks - to apply for a card, send it back and then demand a proper bus pass. But note that for regular bus users this can be a costly option (for example, it's costing me an estimated £300 per year). However, for any pensioner who makes little or no use of buses this does provide a useful, low cost campaigning opportunity.

#### THE ESSENCE OF DEMOCRACY

There is one quality, perhaps above all others, which is essential if a state is to be democratic and that is accountability. Indeed, if corruption is to be avoided and efficient and effective management to survive, this quality is vital in any organisation. Yet increasingly the managerial and political classes have found ways to undermine this principle in order that they personally may benefit and, by so doing, are destroying the foundations upon which our society has been built. In the European Union they have found the perfect mechanism to finally eradicate any vestiges of true democracy in our political system.

There are those who believe that the current mania for out sourcing, off shoring and the breaking up of organisations such as the Civil Service and the railways is intended to somehow make for greater efficiency at less cost but in fact the real desire is to enable incompetent managements or governments to evade responsibility by pointing the finger of blame at the bodies to which they have transferred tasks properly belonging to them. How often do those who have a genuine grievance now find that they constantly receive the answer: "It's not us, you need to speak to them" and are left on a merry go round talking to managers who deny that they are accountable for the problem.

This device is used by the politicians at Westminster, both within the country, when they refer the aggrieved citizens to devolved agencies, and at the European level, where they can now claim that laws and decisions for which they could previously be held to account are now the responsibility of the EU and that the problem must be referred to Brussels. Of course, if one were to attempt to follow this advice one would find that the European Commission and its army of arrogant bureaucrats are actually accountable to no one but a toothless European Parliament whose members are very well paid but whose actual power to change anything is virtually non existent. If this had been the position in the past it would have meant that the permanent secretaries of the British Civil Service would have been able to create laws without fear of scrutiny or control by Parliament. Is it any surprise that the European Commissioners see themselves as the real rulers of the European Union - they are right, they are.

The massive corruption which pervades the EU, and has led to the auditors refusing to sign off the accounts for eleven years in a row, is a result of bureaucrats being freed from accountability, and able to behave as they please, knowing that there is nothing the people can do to stop them.

Without accountability then democracy itself will die. We have seen this so often in the totalitarian dictatorships of the last century, and of this. Unless we withdraw from this undemocratic organisation then soon elections will be nothing but a hollow sham and we will be unable to control those in power.



#### A PROMISED REFERENDUM BY Dr BOB SPINK MP

Since the Treaty of Rome and European Communities Act 1972, Britain ceased to be a legally independent nation. Majority voting in the EU Council of Ministers automatically applies to Crown, courts, Parliament and people "without further enactment" (see Clause 2 – 1 ECA 1972)

**Successive Treaties** have extended the powers of the original Treaty. Now a larger overall Treaty has been proposed under German Presidency, likely to be signed in a final version before the end of this year under the Portuguese Presidency.

On 7th June Foreign Secretary Margaret Beckett appeared before the Commons European Scrutiny Committee to be questioned about the forthcoming Council of EU Ministers meeting planned for 21/22 June. The ESC meeting had been specifically planned to ascertain the proposals by the German Presidency for the forthcoming conference so that our government and people would have some knowledge of the treaty. They were stunned to hear that no draft proposals for the new treaty had been received from the German Chancellor Angela Merkel.

On the evening 19th June, the British Representative in Brussels was handed the draft proposal from the German Presidency (Document 11177/07) for the European Council to issue a "mandate" or instruction for the imminent Intergovernmental Conference of the representatives of EU member states as to how they should go about establishing a "reform" treaty. This document, effectively a German diktat, of 31 pages and two small print detailed annexes was accepted en bloc at the EU Council meeting attended by Tony Blair on 21/22 June without any record of debate. This then became what is now called the "mandate" from the Council to the Intergovernmental Conference for its detailed work of putting together a Treaty incorporating what is already in force together with many controversial additions Subsequent questions have revealed that the government had not received any prior draft of the proposals from the Germans before 19th June.

Minutes of meetings by Select Committees of the House of Commons reveal that the terms of this Reform Treaty agreed on 21/22 June last, had not only been drafted in Brussels under the then President Merkel, Chancellor of Germany assisted by officials of the European Commission but were accepted en bloc by heads of EU Governments, less than two days after their publication. This left no time for national governments to consult their colleagues and still less their departments of State since the proposals were only given to them at most two days prior to the meeting. It would appear that this text was produced by officials of the German for-

eign office assisted by those from the European Parliament and EU Commission.

On Monday 25th June Tony Blair gave a verbal report to Parliament neglecting to mention that a copy of the so-called "mandate" had been lodged in Parliament's Vote Office and available to MPs from the morning of 25 June, so most MPs and all the public were entirely ignorant of the commitment by HMG and Governments of all member states. It had become accepted as a mandate or instruction from the European Council. The Intergovernmental Conference IGC, itself is the body which, in the rules and organisation of the EU is responsible for its own agenda. The European Council has no formal powers to instruct it. Very soon afterwards Tony Blair tendered his resignation to the Queen and a couple of days later both he and Margaret Beckett surrendered their seals of office and responsibility and were no longer directly accountable to Parliament and people for one of the biggest surrenders in British history. Tony Blair left office to the ringing applause of MPs whom he had recently agreed to disempower permanently from the control of many areas of this nation's life

When questioned during a meeting of the European Scrutiny Committee, Minister for Europe Jim Murphy confirmed that the mandate is complete, closed and will not be reopened. The obligations entered into cannot be changed, He stated that the process now is for the "reform" treaty to be translated into legal language into the principal and many other languages of member states, covering some 300 articles and declarations.

In spite of this major and largely unknown departure from established practice, Angela Merkel got her way. The procedures of proposals into the new treaty illustrate central power which could hardly be seen as compatible with any democratic principle. Objections from the Czech Republic and Poland were ruthlessly rejected. Without support from one large member country, they were powerless to resist. Nations of Europe and beyond, opposed the building of a Eurostate by force of arms between 1939 and 1945. The democratic voices of the peoples of Europe must now be heard and acted upon by all peaceful means to reject this EU Constitution/ Reform Treaty.

The European Scrutiny Committee of the House of Commons published a report on 9th October (Ref HC 1014). This concluded that the provisions of the proposed "reform" treaty were, for all practical purposes, the same as the EU Constitution, rejected by the French and Dutch peoples and upon which almost all sitting MPs had, in their election manifestos, promised their electors a referendum.
